Dear Mike:

Here is a possible item for the HFFA Newsletter. A friend alerted me to old an photograph that was on sale on eBay that had a Henry Fry and Leah Fry shown. I did not find a Henry and Leah Fry couple in the Links book, however the time for the item was nearly up, so I put in a bid and got the photo before it got figuring that away, these people were probably related to someone in the HFFA, even if they didn't know it, and that the photo might help someone with their research. The photo is 4" by 5 ½". I scanned the front and rear of the photo, have attached and those images. You can see that in the back row, (from the left) there are two women, then a woman and man, then two men, then a woman and man. The front row appears to be a family unit and then Grandma. Beside the second woman in the back row is written in faint pencil "Leah Fry", and beside the first man is written "Henry Fry". It is a little odd that Leah and Henry are separated,

since a photograph in those days was more formal than our present day snapshots, and people are obviously posed. On the rear of the photo, also in faint pencil is written "Group taken French Creek". Back row Leah Fry wife Henry Fry. Also in back row and then nothing. I tried black light and infrared light, but could not bring up anything else. There is also something embossed along the bottom of the front, but it cannot be resolved. A Google search reveals French Creek Park near Loraine, Ohio. Perhaps you can put some kind of notice about the photo in newsletter. I would be glad to send it (or email a copy) to HFFA member who any thinks these people are related to them. If there is question about this, please let me know.

There was a Fry or Frye family in Birdsboro, but I couldn't make a connection with them. I think they were involved with the steel mill there. I am sure I copied stones from the cemetery, but it is going to take some searching to find them. French Creek would have been a popular place for people to go for an outing. There were hundreds of Fryes in Berks and Montgomery Counties which aren't that far away. It occurred to me that the picture may be of Leah's family. Why identify Henry as a Fry if the others were also Frys? I'll keep looking. You never know what I may run across."

The Genealogical Dating Game

Nothing is more basic to the study of genealogy than dates: date of birth, date of marriage, date of death. But, is there anything more troublesome than accurately recording those dates? It is bad enough that we encounter various documents showing different dates for the same event. We also must contend with a variety of other calendars that affect our research and may contribute to our confusion or misinterpretation of a date.

There is no doubt that the most universal impact on genealogists was the transition from the Julian (Old Style) calendar to the Gregorian (New Style) calendar. On 24 February 1582, Pope Gregory XIII issued a papal bull to regulate the cycle of Christian holidays and correct the discrepancy that had accumulated over the years between the Julian calendar and the vernal equinox. The decree stipulated that ten days were to be deleted from the calendar, so that Tuesday the 4th of October would be followed Wednesday the 15th of October in 1582 and that the date of the first day of the year would be 1 January rather than 25 March.

It took 336 years for all the Christian countries and their colonies to accept the Gregorian calendar. Russia made the change in 1918. Acceptance in the non-Christian world was initially not at issue, but as international communications, commerce and travel developed, the Gregorian calendar was gradually

adopted around the world. The last was China in 1949.

Therefore, in doing our research and analysis, we must take into consideration two issues.

First, we must know the exact date that the change was put into effect in the locale where our ancestors were living. The acceptance of the new calendar varied among the countries, but it didn't just affect Europe. In North America, the English colonies, Canada parts of and northwestern territories that would someday be Washington Oregon changed to the Gregorian calendar in 1752; whereas, the French colonies in Canada and the Mississippi Valley made the change in 1582 and the Spanish colonies in Mexico and the areas of current day Texas, Florida, California, Nevada, Arizona, New Mexico changed in 1584.

Secondly, we must understand the concept of dual dating. For many decades, two calendars were in use as the influence of the New Style calendar spread. This is seen frequently in our research of church registers and civil records in Protestant areas. Dates between 1 January and 24 March started showing up with a dual year. For instance, a date would be written as

20 February 1746/7. Thus there was no doubt about the intended date that the Old Style year (1746) continued even though the New Style year (1747) had started.

Tips: When recording family histories, a date should either be written 20 February 1746 OS (if it was Old Style or NS if it was New

Style) or as 20 February 1745/6. Avoid using a hyphen (1745-6) it can be interpreted as indicating a period of time. Correspondences rarely indicated OS or NS, so contextual clues and national origin should be used to determine the date(s) mentioned. Be cautious when calculating a birth date using years/months/days lived if individual was born before, but died after the Gregorian calendar was implemented.
