### Wil Frye

I have been told my grandparents, Charles and Belle (Smith) Frye, had a difficult marriage. One day in mid-1900, Charles up and disappeared without notice leaving Belle and their two small sons in Indian Territory.

Belle's parents, John and Eliza (Miller) Smith came down from central Kansas to bring her and the boys back to live with them. I have been told that Belle was not allowed by the government to take her sons with her without the written permission of their father. Since he had disappeared, I was told she was delayed several weeks until she was granted custody of the boys.

I e-mailed to Max Best as he is my source of data about Oklahoma as to whom/where I might write to see if there were any records available. He responded that he really didn't know. He did say he left Oklahoma when he was 14. He did know that when his father died in 1948 when he was six, his mother had to go to court to get custody of her own children. He said Oklahoma must have been on an old non-feminine dominated law.

Finally, after all that, my question; has any of our members done research on this law or have information as to how to find records for



mother's having to go to court to get custody of their own children in Oklahoma? If I can get a copy of her custody paper, it will pinpoint when they left for Kansas. My address is on the last page.

## OBITUARY

Editor's Note: The following obituary is for Bob Grundy, late husband of member Marjorie Frye Grundy, Plainfield, IN.

### ROBERT GRUNDY



**PEORIA** - Robert H. "Bo" Grundy, 94, of Plainfield, Ind., formerly of Peoria, passed away Friday, Sept. 9, 2006, at St. Vincent Hospice in Indianapolis, Ind.

He was born May 31, 1912, in Peoria, Ill. He started flying in 1927 at Varney School of Flight at Mount Hawley Airport in Peoria, Ill. He traveled to Central America and flew with TACA Airlines in the mid-1930s. He dusted cotton with the Delta Cotton Corporation in the late 1930s. While working for Delta, a Huff Daylan he was flying caught fire and crashed. Now restored, the plane was presented to the Smithsonian Air and Space Museum and presently hangs in Delta's headquarters in Atlanta, Ga.

During WWII, he was the Assistant Chief Civilian

pilot of the 311th Aircraft Detachment, located at Curtis Steinburg Airport in East St. Louis, Ill., providing basic flight training for Army Air Corps cadets. Mr. Grundy was a Civil Aeronautics Administration Aeronautical Inspector from 1943 to 1945. His experience allowed him to transfer to the CAA's Indianapolis Technical Development Center for the Civil Aeronautics Administration and became a test pilot from 1945 to 1960. He was instrumental in the successful completion of the "One Year Mandate" for the development of the VOR airways navigation system that is still in use worldwide today.

During his time as test pilot, he had the opportunity to fly on a regular basis a 247 Boeing that Roscoe Turner and Clyde Pangbourne flew in the first London to Melbourne Race of 1934. The plane is presently hanging in the Smithsonian Air and Space Museum in Washington, D.C.

After retiring from flying in 1960, he became a farmer and actively farmed through 1972 when he retired. He remained actively involved with the family farm until 2001.

He was a member of and former governor of the Quiet Birdman Aviation Fraternity, OX-5 Club, Early Bird Association, Top of the World Club of 1951 and the Indiana Nut Growers Association.

In 1990, he was selected to the OX-5 Aviation Pioneers Hall of Fame.

Survivors include his wife of 67 years, Marjorie Grundy; sons, James (Diane) Grundy of Hickory Corners, Mich., Joel (Margit) Grundy of Huntington Beach, Calif., and Denny (Patricia) Grundy of Trabuco Canyon, Calif.; a daughter, Kathleen (Don) Knuth of Plainfield, Ind.; and nine grandchildren.

Visitation will be at Hampton-Gentry Funeral Home in Plainfield from 2 to 5 p.m. Tuesday,

Sept. 12. Burial will be at Springdale Cemetery in Peoria, Ill.

## **SEARCHING DUSTY FILES OF COLORADO – PART 2**

My research in Denver took all of Monday and the morning of Tuesday, June 5 and 6. The afternoon of Tuesday I spend with a third cousin and her husband who I am related to through the Smith line of my Grandmother Frye. Her detailed records reminded me of the records Charles (our President) has for the Frye line. They go on forever and ever.

I left Denver early Wednesday morning for Colorado Springs. I arrived too early to check into the motel so I visited the Evergreen Cemetery where I had been told my oldest sister Josephine was buried. The cemetery office did locate her there. I was directed to Block 107, Lot 62. and given a map of block location which I found easily. However, there were no markers for lots. Approximately half of the block was without grave stones or markers.

Back I went to the office and asked how to find Lot 62. They check their detailed records and said that Block 107 was in the oldest section of the cemetery and it had no lot markers. They contacted a grounds keeper by walkie talkie asking him to meet me at Block 107 to show me the location of Lot 62.

He was waiting for me by the time I had returned to Block 107 and pointed out where Lot 62 was located in approximately the south center of the Block 107. He said each lot consists of six burial plots and are listed by directional location. On the west central portion of the lot was one tombstone having the name of Frank Harold Smith, who I knew to be a younger brother of my grandmother Frye. Back to the office I went asking if they could tell me who was buried in each of the

six burial plots by specific location within the Lot. Only two were buried, Frank in Lot 62 West Central space and Josephine Belle Frye in space South West. The remainder was empty. I then asked if they could tell me who owned Lot 62. They found those records in the ownership computer data file and said the western three spaces (NW, CW, & SW) were owned by Xel Smith. I knew Harold's widow's name was Ethel so I assumed that her name was scrambled when transcribed for the computer. I would guess the unused plot was planned for her. She was a Keller and is buried with her parents in North-East Ellsworth County, Kansas, close to where my Grandmother Frye is buried with her parents (also Ethel's parents-in-law). She must have



graciously offered the third plot to my parents for Josephine.

I felt Josephine needed a stone marker. I ordered one from Spence Memorials and requested them to place the stone on her plot, take a picture and mail it to me. I received the picture by the end of July.



I next went to a Colorado State office building to request birth and death certificates for Josephine and a birth certificate for my late brother Sherrill Hudson Frye. Colorado has all their vital statistics on computer files located in Denver apparently remotely accessible from state offices located in county seats. Their policy is to supply birth certificates on request but require death certificates be mailed out.

After taking my written order, the clerk went to a computer terminal to pull up the birth certificates. After 15 or so minutes she went to a private office. After another 30 minutes she came back with a copy of Josephine's death certificate and a certificate of vital record for Sherrill's birth. She said she had been on the phone to Denver. Denver office had search the entire state of Colorado and could not find a birth certificate for Josephine. She brought me the death certificate for Josephine showing she was born in Colorado Springs showing her birth place as being Colorado Springs. My father, J. H. Frye, was shown as informer. New mystery.

**My brother's vital record certificate was given to me in lieu of a birth certificate. It**

had on it only the basic information. She said Denver would not authorize a copy of the birth certificate even though I was a next of kin. She said something about I did not have proof of his death with me and they were concern about someone assuming his identity. I said I would be willing to accept a birth certificate with it being stamped in red "For Family History Use Only"; she was not willing to give me one that way. So, I do not have the other information normally contained on the birth certificate itself. I will write directly to the State office in Denver.

The day was pretty much over. I checked into the motel and spent the evening reviewing my notes. The next day (Thursday), off to the Colorado Springs Library to search city directories and newspapers.

### **UPDATE**

### **HFFA Web Site**

**[www.hfrey.org](http://www.hfrey.org)**

I have updated the home page which contains the instructions for using the site. I would recommend printing out a copy as to have it handy while you're exploring the different sections.

Chris and I have now added copies of the first five Journal issues of Volume 1 to the web site (which are no longer available in the printed version). Our plan is to add the remaining issues of Volume 1 during 2007 which are available in printed form from Tommy Wiggins. The journals are being scanned in gray tone which allows both the printing and the pictures to be fairly clear. However, I would recommend you to order from Tommy the printed copies for clear crisp

printed pages. All four issues of the 2006 newsletters are also included.

We now are updating the rosters at the end of each month and placing a copy on our web site as well. Those members who do not have access to the internet will continue to receive a printed copy with the November issue of the Newsletter.

All documents may be printed out once you have signed on as a member. Just click the pointer anywhere on the page and use your local printer.

We believe the key word search function is very powerful. Click on the menu search key word, key in a word, name, or phrase, click the search button. If what you keyed in is found on one or more documents, a list will appear in the right column showing the document name and the page within the document where your entry appears. If you click on a page, the page will quickly appear in the right column. If you click on the document name, you can then download the whole document itself (it could take several minutes to download depending on the speed of your internet connection). Then you can print out the full document where the entry appears.

If you key in a common word or phrase or a name which might appear frequently (such as Heinrich Frey), you might end up with a large number of page locations displayed. Chris has limited the number of location pages displayed to 250. On occasions, you might have to search for more unique entrees to have fewer lines displayed.

For example if you desired to know if the word "Astrophysics" appears in any of the documents, key in astrophysics and click the search button. You will get the following displayed:

If you click on the first one found, Page 3 of the Fall 1992 Journal will appear. It shows the word appearing in the first line of the next to last paragraph. The late Bert Frye had a Master's Degree in Astrophysics from Miami University (of Ohio).

If you click on the second entry, the PDF icon for the full Fall 1992 Journal will appear. Click on the icon, a copy of the file will be downloaded. (It could take several minutes to download). You can now print out the full Journal on you local printer.

Try putting in different names or phrases and see what you can find. As I am writing this, I put in "featured fry". I received 23 hits. Abraham Fry gave me 24 hits. Both of these will grow in hits as we add more journals. This technique will help in finding locations of items of interest.
